## Jordan School District LEA Parent and Family Engagement Policy November 2025 - November 2028

- 1. Jordan School District will involve parents at Title I schools in the development of the Jordan District Title I Utah Grants plan through the following actions:
  - a. Parent Representatives will be included in the Parent Engagement Steering Committee which will review data and give feedback on Title I Plan needs as listed in #2 below.
  - b. A review of the school-wide Title I plan will be completed at each Title I school to address the needs of the school and strategies from those plans will be included in the Jordan District plan.
- 2. Jordan School District will involve parents in the process of school review and improvement, as well as an evaluation of the District Local Education Agency (LEA) and school Parent and Family Engagement policy, through the following actions:
  - a. A Title I Advisory Committee will be assembled every three years, composed of the following members:
    - i. Title I LEA Coordinator and Support Committee Members
    - ii. Title I School Administrators
    - iii. Title I School Instructional Coaches/Specialists
    - iv. Title I School Support Staff or Licensed Staff Representative
    - v. Title I School Parents (minimum 2 recommend a School Community Council member)
  - b. A School-wide Title I parent survey will be administered during the 3rd quarter of each school year and data will be analyzed at each individual Title I school prior to updating their Title Plan.
  - c. The role of this advisory committee will be to review Title I Parent and Family Engagement policy and data at the school or district level that will inform the Jordan District Title I Utah Grants Plan regarding parent and family engagement.
- 3. Jordan School District will provide support and technical assistance to aid schools in effectively implementing parent and family engagement activities and building the school's capacity for strong parent engagement, which increases student achievement, by:
  - a. Providing support and resources for the school's Instructional Coaches/Specialists through on-site support and networking.
  - b. Implementing District programs and connecting to state agencies.
- 4. Jordan School District will incorporate parent and family engagement strategies that support learning, transition between home and school, and parenting needs through:
  - a. Accommodating activities that increase literacy, math, health & wellness, and social skills at home and in the community.
  - b. Providing support for parenting and life skills through ongoing classes in school-based Family Learning Centers.
  - c. Removing barriers for parental participation (i.e. parents who are economically disadvantaged, disabled, immigrant, migrant, Limited English Proficient, or ethnic minority).
